INTRODUCTION

"Through the Bennett Thrasher Foundation, Bennett Thrasher's partners and associates give their talents, gifts and service to charitable organizations fostering the long term development and success of individuals in the Greater Atlanta Metropolitan Community."

Established in 2003, the Bennett Thrasher Foundation is our firm's vehicle to give back to our local community. Through service projects and financial grants, the Foundation supports charitable organizations primarily in the metropolitan Atlanta area. The Foundation was initially governed by an all-partner board, but in 2006, Bennett Thrasher partners elected to have the Board comprised of and governed by an all-associate board which continues today.

One of the Foundation's primary objectives is to complete volunteer service projects throughout the year. Bennett Thrasher provides each associate with 16 hours of paid time off per year to participate in volunteer service projects. The Service Committee, one of the subcommittees of the Board, is charged with overseeing and coordinating these service projects which typically are comprised of four large-scale projects completed in one day (e.g., Habitat for Humanity build, Junior Achievement teaching, Trees Atlanta planting) and several smaller-scale projects (e.g., MedShare sorting, Must Ministries food preparation, GSCPA Georgia Food Fight) each year.

The second objective of the Foundation is to give cash grants to eligible non-profit organizations located mainly in the Greater Atlanta Metropolitan Community. Submission guidelines for grant requests are posted on the Bennett Thrasher intranet and all grant requests must be submitted by a Bennett Thrasher partner or associate. After applications are received, they are reviewed and prescreened by members of the Grants Committee, another subcommittee of the Board. The Foundation Board then considers all grant requests recommended by the Grants Committee and determines which organizations will receive grant awards, as well as the level of funding each will receive, by a majority vote. In its deliberations, the Board considers factors such as the mission and purpose of the organization, intended use of funds and the potential impact of our support. Additionally, the number and amount of grants awarded varies per year based on the number of grant requests received and the total amount of funding available for distribution.

The Bennett Thrasher Foundation is a Private Foundation and is tax-exempt under Title 26 U.S.C. 501(c)(3) of the Internal Revenue Code. Since its inception, the Foundation has given close to \$2,000,000 in grants and thousands of hours of service to help improve our community.

Refuge Coffee

Refuge Coffee Co., established in 2014, rests its heart and its location in a small city just outside of Atlanta, GA called Clarkston. The UN resettles 2,500 refugees each year in Clarkston. With 145 countries, 761 ethnic groups and 60 languages spoken, TIME magazine has titled the city to be "the most diverse square mile in the country." Majority of residents living in Clarkston have fled to the U.S from violence and war in their own countries and are now suffering the devastating effects of poverty and PTSD.

The goal of Refuge Coffee Co. is to provide a safe place to anchor Clarkston's refugee community. Refuge Coffee Co. relentlessly pursues their goal to provide employment and job-training opportunities to resettled refugees, to create a unique, welcoming gathering place in Clarkston, and to tell a more beautiful refugee story to Atlanta.

Currently, Refuge Coffee has started out with a coffee truck to begin building their vision. But in the future there are plans to start a coffee shop, roasting operation, and maybe even expand into another truck due to demand for catering and movie set deliveries.

Wholesome Wave

Founded in 2009, Wholesome Wave Georgia (WWG) believes that all Georgians should have access to healthy, wholesome and locally grown food.

In Georgia, more than 1.7 million people are considered food-insecure and receive federal nutrition assistance (SNAP/Food Stamp) benefits. The high cost and low accessibility of fresh foods leave these 1.7 million with limited options to feed their families. Food insecurity is linked to poverty, obesity, and other diet-related illnesses. The effect of food insecurity on America's families is evident: approximately 65% of adults and 34% of children (ages 2 to 19) are overweight or obese.

WWG encourages us to rethink the cost, accessibility, and affordability of fresh, wholesome foods in Georgia. Our mission is to increase access to fresh, healthy, locally grown food for all Georgians. We work towards our mission through two core programs: Georgia Fresh For Less and the Fruit & Vegetable Prescription Program.

Their programs include the following:

- Fruit & Vegetable Prescription Program: This program promotes affordable access to
 fruits and vegetables and healthy eating in under-served communities through partnerships with healthcare providers, community organizations and fresh produce retailers.
 Through the program, healthcare providers give families innovative prescriptions that
 can be spent on fruits and vegetables at participating farmers markets.
- Georgia Fresh for Less: Wholesome Wave matches SNAP/EBT dollars--dollar for dollar--at participating farmers markets. When shoppers spend \$10, they get \$20 worth of fresh, local food. Shoppers pay less for fresh and local food that is higher quality and more nutritious.

Sunshine on a Ranney Day (SOARD) is a 501(c)(3) nonprofit approved organization based in Atlanta, Georgia, founded in 2012 by Peter and Holly Ranney.

The vision of Sunshine on a Ranney Day is to renovate homes for children with special needs and restoring hope for families. We are a licensed general contractor that specializes in wheelchair accessible bathrooms, dream bedrooms, in-home therapy rooms and wheelchair ramps/lifts. We take great pride in the quality of our work, professionalism and passion that is put into each makeover. Through our partnerships with local companies and donors we are able to offer our makeovers to families at no cost.

In 2012, Sunshine on a Ranney Day performed their first makeover for an 11 year old boy who always wanted a military bunker bedroom. This special child was Mathew Majka who was battling a brain tumor. From that point on, the husband and wife duo, Peter and Holly Ranney, realized this mission was bigger than they imagined.

Holly is a graduate of High Point University with a degree in Interior Design and Home Furnishings Merchandising. She spent 12 years as a buyer for Rooms To Go Kids. She traveled extensively around the world working on product development and developed strong relationships in the furniture industry. Peter is a graduate of Clemson University with a degree in Accounting. He grew up in the building industry and worked several summers with his Dad in the family business doing construction. At that time he thought he wanted to get out of construction and pursue a career in accounting. Little did he know that he would end up back in construction. Now he is a licensed general contractor and heads up all the construction projects for Sunshine on a Ranney Day. He also owns the residential remodeling company Ranney Blair Construction.





LOOKING AHEAD

This past year, the firm hosted several service opportunities on our annual service day, and Bennett Thrasher associates individually chose which service projects they wanted to participate in. In the past, the firm has concentrated exclusively on one firm wide project each year to help alleviate a particular need in the community. This year, however, it was exciting to see the exponential impact our associates had in one day participating in various service projects throughout the Greater Atlanta Metropolitan Community! We believe this new approach to our annual firm wide service event will continue to be a positive way to promote greater philanthropy in our community while strengthening the relationships between Bennett Thrasher associates. In addition to the firm wide event, we will continue to give our associates the ability to volunteer in various service projects throughout the year. We want to ensure that everyone learns more about our community and receives the training, support and guidance needed to make a positive impact using each associate's unique talents.

The Foundation is committed to helping the Atlanta community. Giving our time and resources to create positive change within our surrounding community is the cornerstone of everything we do. We encourage employees to get out and make a difference in their community and the Foundation is proud to be a catalyst to stimulate a succession of giving.
